"European Education on values and humanity" (EEVH)

Humanitarian knowledge, human rights and "good" governance": state, academic and human rights advocacy institutions in Lithuania for promoting human rights and education of professionals from **CIS** countries and the countries of Eastern Partnership

September 19-23, Vilnius, EHU







Nowadays, the need to strengthen the components of value perception and at the same time practical implementation of humanitarian and social knowledge, to change the paradigm of methods used in public administration, as well as in professional and social activities, to form new models of behaviour in the direction of real democracy, participation and culture of human rights is becoming increasingly obvious.

The experience of democratic reconstruction based on constitutionalism, the rule of law, as well as the cultural, linguistic and geographical ties of Lithuania with the surrounding nations, the high scientific and pedagogical potential of the universities of this country can be used more widely to prepare a new generation of specialists who can change the development of their countries in the direction of "good" governance, human rights, democracy and constitutionalism.

Surveys among lawyers and other specialists in Azerbaijan, Belarus, Moldova, Ukraine, and Russia show that there is great interest in obtaining European education among those who have already graduated in their countries and are engaged in professional activities. At the same time, knowledge of foreign languages still remains a problem; therefore, teaching in Russian with the development of competencies in other languages is especially urgent.

European universities in the field of teaching international and European law have formed approaches to the development and implementation of programs based on the idea of humanizing vocational education by including human rights law as an end-to-end element of such programs, with the goal of creating a new elite that is fundamental to the democratic foundations of public order, the rule of law and constitutionalism.

Only combined efforts of academic and state institutions as well as the involvement of civic initiatives and individual experts / teachers can create an educational space in which the transfer and accumulation of knowledge, skills and value approaches will take place for those who in the future will transform legal systems of their countries.

EHU has unique experience and a body of professionals working in the field of formal and non-formal education of representatives of various professional groups in human rights. Three projects that have been implemented in recent years - Training of lawyers in international law (together with the Norwegian Human Rights House Foundation), J. Monet Chair "Teaching EU Constitutional Law in Eastern Europe" (with the support of the European Commission), and the joint project Nordic Summer University - EHU, - serve as the basis for the development of programs in the field of constitutionalization of public order. From 2007 to the present, EHU, together with a network of Human Rights Houses, the Constitutional Court of Lithuania, the Belarusian Human Rights House and other organizations in Lithuania and Belarus, works on the transfer of theoretical knowledge in the field of humanities to those who do practical work in the field of promotion and protection of human rights. The J. Monet Chair project formed the basis for the dissemination of knowledge in the sphere of EU constitutionalism. The Nordic Summer University - EHU project, implemented since 2013, has organized 2 three-year research cycles - "International Relations and Human Rights" (2015-2018) and "Patterns of Dysfunctions of Modern Democracy" (2018-2021), which brought together researchers from the Nordic countries, Lithuania, Latvia, Estonia, Belarus, and Poland.

A community of professionals united by the understanding of the importance of promoting human rights and the skills of applying humanitarian knowledge in professional and public life has formed among the students and alumni of EHU, most of who return to Belarus after completing their studies.

In Belarus today many of EHU alumni work in the field of protection and promotion of human rights and environmental protection, and / or collaborate with organizations and activists that aim to promote humanitarian values and a culture of human rights.

**EHU initiates a wide project** to train specialists who, sharing the values in the field of human rights, constitutionalism and public administration, after studying the basics and mastering the skills of effective public administration based on human rights, will apply them in their legitimate professional practice and / or civil activity.

**EHU invites** Lithuanian academic, state and public institutions **to work together** to create programs that will help students from former Soviet Union countries learn new skills and abilities that they will apply to increase respect for human rights and understanding of each person's responsibility to participate in governance at the national level, as well as to empower the individual to act in order to develop the capabilities of each individual and to help prevent the stigma of social apathy, marginalization, intolerance and violence in society.

The first step towards the establishment of the consortium "European Education on values and humanity", the purpose of which is effective cooperation in the field of transferring knowledge, experience and best practices in the field of university education, will be a conference, which will serve as a common platform for discussion.

The conference simultaneously finalizes the project of J. Monet Chair in the field of teaching the constitutional law of the EU and ensures its further development in new forms and on new platforms.

The conference will result in the agreements, as well as a list of recommendations, documents and plans for cooperation in the field of transferring knowledge, experience and best practices in the field of university education within the consortium "European Education on values and humanity", as well as the community of students and alumni of EHU "Humanities university and humanitarian practices".

The conference will be held at several venues where parallel events will take place, united by the common goal of humanizing educational projects. One of the side events of Nordic Summer University - EHU - Coordination meeting of the NSU Board and research projects (circles) coordinators (FM3/2019) will be held from September 20 to 23. For the other three events, the conference will end on September 21.
