Contemporary Challenges to Constitutionalism



#### Prof. Dr. Hanna Suchocka

Dr. Hanna Suchocka – politician, diplomat, law professor and Honorary President of the "European Commission for Democracy through Law" (Venice Commission). She began her political career in 1980 as the (Venice Commission). She began her political career in 1980 as the advisor for Solidarity movement (Solidarność), was elected as a Solidarity candidate to the Polish Parliament initiating the political transformation in 1989. H. Suchocka served in Polish Sejm until 2001. In 1992 she was elected as a Prime Minister of Poland, the first female prime minister in the history of the country. From 1997 to 2000 she served as the Minister of Justice and Attorney General and then from 2001 until 2013 – as an Ambassador of the Republic of Poland to the Holy See. H. Suchocka is now a professor at the Constitutional Law Department at the Adam Mickiewicz University of Poznan.



#### Prof. Dr. **Cesare Pinelli**

Dr. Vytautas Sinkevičius – Professor Emeritus at Mykolas Romeris University (Lithuania). Following his graduation from the Faculty of Law of Vilnius University in 1975, V. Sinkevičius remained at the Department of Public Law of the same faculty as a university lecturer. In 1981–1990, he worked for the Presidium of the Supreme Council. In 1990–1999, he was Deputy Director and subsequently Director of the Legal Department of the Supreme Council-Reconstituent Seimas (later—of the Seimas). He was a member of the group for the preparation of the draft Constitution. In 2001, he defended his doctoral thesis and was awarded a PhD in law. In 1999–2008, he served as a justice of the Constitutional Court.

Dr. Wen-Chen Chang is Distinguished Professor of National Taiwan University College of .aw and Joint-Appointment Professor at National Yang Ming Chiao Tung University Law and Joint School of Law.

She has received numerous awards for here teaching and research including recently the Excellence in English Teaching Award by National Taiwan University in 2021 and the Outstanding Research Award by Taiwan's Ministry of Science and Technology in 2015.

Žalimas was awarded the Grand Cross of Commander of the Order of Lithuanian Grand Duke Gediminas (of the Republic of Lithuania) in 2018; the "Order of Honour" (of the Republic of Moldova) in 2016, as well as a number of other state awards.

He is an author or co-author of more than 10 books on public international law and constitutional law, more than 160 scientific articles and more than 80 other articles published in different journals. In 1991 he participated in the defence of the Republic of Lithuania from the Soviet agreesion.

#### Prof. Dr. Renáta Uitz

Dr. Renáta Uitz started teaching comparative constitutional law at Central European University in 2001. In February 2022 she joined CEU's Democracy Institute as a co-director. Her major research interests lie in transition to and from constitutional democracy, the protection of individual autonomy and religious liberty. Her current work focuses on liliberal constitutional practices in the European Union and the normalization of liliberal constitutional practices in the European Union and the normalization of liliberal constitutionalism around the world. Her most recent book publication is the <u>Routledge</u> <u>Handbook of liliberalism</u>, co-edited with András Sajó and Stephen Holmes (Routledge 2021). He holds LLM from Belarusian State University Law Faculty and doctoral degree in Constitutional Law from Yaroslav Mudryi National Law University in Kharkiv, Ukraine. He has more than 130 scientific publications, including several monographs devoted to the problems of human rights and constitutional law issues. A. Vashkevich is an expert of the Council of Europe and United Nations as well as the member of the OSCE/ODIHR Panel of Experts on Freedom of Peaceful Assembly and Association; co-author of the joint OSCE/ODIHR–Venice Commission Guidelines on Freedom of Peaceful Assembly.
